Dear Resident, Family Members, Loved Ones, and Team Members,

Bellaire at Devonshire continues to have scheduled Resident visitation. The following key changes remain in place:

- Residents and visitors may visit without distancing and source control masks if alone in the resident's room and if both the resident and visitor are fully vaccinated. If the visitor is not vaccinated, they can visit with the fully vaccinated Resident alone in the Resident's room without distancing while wearing well-fitted source control mask. The visitor must continue to wear a source control mask and physically distance from associates and other Residents and visitors that are not part of their group at all other times while in the Community.
- Communal dining and activities may occur without physical distancing if all Residents are vaccinated.
- We are still allowing 2 visitors per each in-room scheduled Resident visit.
- Visitation can be scheduled in the Resident room, Putnam Room, or outdoors.

Visitation will be permitted for all Residents **except** during the following circumstances:

- Unvaccinated Residents if the county positivity rate is greater than 10 percent and less than 70 percent of residents in the Community are fully vaccinated.
- Vaccinated and unvaccinated Residents with COVID-19 infection until they have met criteria to discontinue Transmission-Based Precautions.
- Vaccinated and unvaccinated Resident in quarantine until they have met criteria for release from quarantine.
- The Community is in outbreak status. The Community would follow guidance from the state and local health authorities and CMS on when visitation should be paused.

Please encourage your friends and family to call and schedule an appointment for Resident visitation. We want to accommodate all Resident visits; however, we must continue to track movement within the Community. Scheduled visitation will take priority over walk-in visits. In addition, your friends and family can subscribe to our text news blast by texting "Devonshire" to 855-906-2913 to stay updated on the Community's visitation protocol. For your convenience at the sign Kiosk, we have personal protective kits that include masks, hand wipes, and hand sanitizer. Our top priority remains the safety and well-being of our Residents while continuing to have group dining, group activities, and visitation.

Effective June 1st Resident room tray fees will be reinstated for all meals. The cost will be \$3.00 per tray. Medical exceptions must be approved by Nursing. We encourage all Residents to come out to communal dining and activities for increased socialization and well-being.

Just a friendly reminder of our referral bonus program. If you refer someone to our Community and it results in a move-in greater than 30 days, you could be eligible for a substantial discount on a future invoice.
